JTC 1 instructs the JTC 1 Secretary to provide a report on the activities of the Ad Hoc at the 2009 JTC 1 Plenary meeting in Israel.

**Resolution 10: Maintenance Team for IT Vocabulary**

JTC 1 approves the revised Project Description for the Maintenance Team for IT Vocabulary contained in JTC 1 N9190 and confirms its Terms of Reference as follows:

Terms of Reference:

- Review, update and consolidate international vocabulary standards published by JTC 1, as approved by the Validation Team composed of participating National Bodies (NBs). This may include elimination or consolidation of some terms and definitions, and editorial revision. However, no such elimination, consolidation or editorial revision (other than grammar and punctuation) will take place without the review and consent of the JTC 1 Subcommittee responsible for the development of the term and/or definition, where one exists;
- Work with Subcommittees developing vocabulary and assist them in integrating their vocabulary into the JTC 1 corpus;
- Work with ISO in providing regular updates to the ISO Concept Database. Development of new vocabulary and concept maps is not within the initial scope of the Maintenance Team.

The Maintenance Team will develop the IT Vocabulary project according to the "Standards as Database" procedures as documented in STD\_DBSN52 (also Annex ST of ISO Supplement). The outcome of its work will be a single-part international standard, retrievable in an alphabetic sequence appropriate to the language, in accordance with the previously JTC 1-adopted project plan. It is expected that the results of the Maintenance Team's efforts will be submitted to ITTF after the validation exercise is completed in the 3<sup>rd</sup> Quarter 2009 for publication as a database; JTC 1 will consult with ITTF to determine in what form the document will be disseminated in accordance with all applicable ISO/IEC directives.

As Subcommittees develop new IT terminology, JTC 1 reminds the Subcommittees that this information should be submitted to the Maintenance Team for uploading into the ISO Concept Database.

## **Resolution 12 – Liaison with IEC TC 100, Audio, Video and Multimedia Systems and Equipment**

JTC 1 requests that its SCs, in particular SC 6, SC 23, SC 24, SC 25, SC 28, SC 29 and SC 34 who already have established liaison relationships with specific TAs, consider circulating their NPs to IEC TC100 for comment when issuing the NPs to their National Bodies for ballot. JTC 1 further requests that the JTC 1 liaison officer to IEC TC 100 makes a similar request to TC 100 at their forthcoming plenary meeting in Sao Paulo so that JTC 1 and its SCs are notified of relevant IEC TC 100 NWIs in particular those in TA2, TA4, TA7, TA8, TA9 and TA11 and reports back to JTC 1.

Additionally, when new JTC 1 SCs, WGs, JWGs, SGs are established, or scopes are changed significantly, JTC 1 will circulate the scope and initial work programme to IEC TC100 for information and will request a similar exchange of IEC TC100 information (regarding new TAs and PTs) so that appropriate liaisons can be established between new groups and existing groups in either organisation.

## **Resolution 13 – Cooperation Between SC 34 and OASIS on Maintenance of ODF/ISO/IEC 26300**

- a) JTC 1 recognizes the timely response (JTC 1 N9398) from OASIS to the SC 34 liaison statement (SC34 N1095/JTC 1 N9416), and thanks OASIS for the new draft errata to ODF 1.0. ## **Resolution 16: Flow of Information Between JTC 1 and ITSIG**

JTC 1 reminds its subgroups and its Liaison Officer to ITSIG of the importance of ensuring that JTC 1 input to ITSIG is coordinated amongst the various JTC 1 activities, such as the SWG-Accessibility, the SWG on Archival and Retrieval Mechanisms and the SWG-Directives Ad Hoc on Annex H. It is also crucial that the Liaison Officer to ITSIG consult with representatives identified by the above groups prior to attending ITSIG meetings and that information from ITSIG be shared with JTC 1 in a timely manner to ensure that JTC 1 entities and members have sufficient opportunity to review the ITSIG information and ensure this coordinated input is provided back to ITSIG.

**Resolution 18 – Scope of SC 27**

JTC 1 approves the revised scope of SC 27 as follows:

*The development of standards for the protection of information and ICT. This includes generic methods, techniques and guidelines to address both security and privacy aspects, such as:*

- *Security requirements capture methodology;*
- *Management of information and ICT security; in particular information security management systems (ISMS), security processes, security controls and services;*
- *Cryptographic and other security mechanisms, including but not limited to mechanisms for protecting the accountability, availability, integrity and confidentiality of information;*
- *Security management support documentation including terminology, guidelines as well as procedures for the registration of security components;*
- *Security aspects of identity management, biometrics and privacy;*
- *Conformance assessment, accreditation and auditing requirements in the area of information security;*
- *Security evaluation criteria and methodology.*

*SC 27 engages in active liaison and collaboration with appropriate bodies to ensure the proper development and application of SC 27 standards and technical reports in relevant areas.*

**Resolution 19 – Establishment of Joint Working Group between ISO/TC 42 and JTC 1/SC 23 for the development of optical storage media longevity testing**

JTC 1 approves the establishment of a Joint Working Group between ISO/TC 42 and JTC 1/SC 23 for the development of optical storage media longevity testing under the terms and conditions specified in document N9325. JTC 1 notes that the JWG will be administered by SC 23 and that the Convenership of the JWG is to be determined between SC 23 and TC 42. A report of the activities of this group should be submitted to the JTC 1 Plenary in Israel as part of the SC 23 SC report.

JTC 1 requests that the proposed agenda be submitted to JTC 1 no later than 30 January 2009.

Based on the results of the Technology Watch session at the 23<sup>rd</sup> Plenary, JTC 1 instructs its Special Working Group-Planning to further explore standardization opportunities in the field of Green IT, sustainability in IT and related areas in cooperation with relevant JTC 1 SCs, other technical committees, Liaison Organizations and fora.

Based on the results of its research, JTC 1 delegates authority to its SWG-Planning to propose actions, as appropriate, to progress this work, and instructs the SWG-Planning to provide a report together with appropriate recommendations at the next Plenary meeting.

### **Resolution 33 – International Standards Training**

Based on the discussion in the Technology Watch session at the 23<sup>rd</sup> Plenary and realizing the benefits of educating future Standards Users and Developers, JTC 1

- notes that ISO, IEC, WSC and several National Bodies within JTC 1 have on-going education activities supporting JTC 1 work and

- notes that SC 36 has expressed willingness to coordinate development JTC 1 training material
- encourages all National Bodies to submit relevant information about their standards education programs to SC 36 and ITTF in an attempt to co-ordinate such activities and share resources

#### **Resolution 34 – African Languages and Keyboard Layouts**

Based on the results of the Technology Watch session at the 23rd Plenary, JTC 1

- instructs its Secretariat to distribute the presentation on "Writing African Languages: The Keyboard Issue" to SC 35/WG 1 for further consideration and
- requests SC 2 to check whether all characters needed for the representation of the noted African languages are indeed contained in ISO/IEC 10646 and address any omissions.

#### **Resolution 35 – JTC 1 Long Term Business Plan**

JTC 1 approves document N9344 (as revised) as the JTC 1 Long Term Business Plan (LTBP) and agrees to work on the activities defined in this document.

JTC 1 instructs the SWG-Planning to review the LTBP as part of its yearly activities and to propose necessary changes to the JTC 1 Chairman. The updated LTBP will be approved at each annual JTC 1 Plenary meeting.

  - Provide a self-assessment of the efficiency of the process, in terms of NWI, new liaisons, etc...
- Identify to the SWG-Planning all its key partners, e.g. liaison organizations (this can be copied from their business plan)
- Explain how they engage other organizations (PAS Submitters, external Liaisons, etc) in their business planning activities.

JTC1 establishes a JTC 1 Working Group on the Corporate Governance of IT with the following Terms of Reference:

- 1) To develop standards and related documents on Corporate Governance of IT, to include:
  - a) Performing a gap analysis and defining a framework and models for the Corporate Governance of IT and its relationships with associated functions and systems for the management of IT activities;
  - b) Standardisation and harmonisation of terminology related to Corporate Governance of IT; and
  - c) Ongoing maintenance of ISO/IEC 38500 and development of associated guidelines (subject to needs identified by the Study Group formed under SC 7 Resolution 1081),  
but excluding the operational management of IT,
- 2) To seek initial liaison relationships with:
  - a) SC7
  - b) SC27
  - c) ISO TC 68
  - d) ISO TC 215
  - e) ISACA/ITGI
  - f) ItSMF-I
  - g) Other relevant bodies, potentially including: SC6, SC17, SC23, SC31 and SC37,
- 3) Membership of the Working Group being open to representatives from all National Bodies,

JTC 1 approves the National Body of Australia as secretariat and John Graham as convener (subject to approval by the National Body of Australia) of the Working Group.

Objection: France, USA, India, Germany, Singapore

Abstain: Japan

**Resolution 42 - Harmonisation of ISO/IEC 14443 standard with standards on Near Field Communications (NFC)**

JTC1 recognises the establishment of a study group in SC 6 to address the harmonisation of the NFC standards and ISO/IEC 14443 with SC 17's collaboration through their on-going liaison relationship. JTC 1

encourages SC 6 and SC 17 to continue this harmonisation effort between the ISO/IEC 14443 series of standards from SC 17 and the NFC standards from SC 6.

JTC 1 encourages SC 6 and SC 17 to first draw-up and agree on a list of technical points to address in order to perform this harmonisation. Ecma International as the originator of the NFC standards is invited to be actively involved in this effort.

SC 6 and SC 17 are requested to report on the aforementioned joint harmonization effort at the next JTC 1 plenary in 2009.

**Resolution 43 - Proposal for a new field of technical activity on Fraud countermeasures and controls (ISO/TS/P 206/JTC 1 N9415)**

JTC1 instructs the chairmen of SC 17, SC 27, SC 29 and SC 37, together with the JTC 1 Chairman, to develop a consolidated report summarising those parts of their respective sub-committees' work programmes and areas of study relevant to the proposed establishment of a new field of technical activity on Fraud countermeasures and controls. JTC 1 notes that a ballot on the establishment of a new ISO TC is currently underway and closes 2009-01-10. Should the ballot be approved and the new TC established, the consolidated report is to be forwarded by the JTC 1 Secretariat to the new TC with a request to establish the appropriate liaison relationships with JTC 1.

**Resolution 44 – Re-establishment of Study Group on Sensor Networks**

JTC 1 reconfirms the Study Group on Sensor Networks (SGSN) with the following Terms of Reference:

- 1) Review the current definitions and visions and requirements for target applications of Sensor Networks within JTC 1 and outside JTC 1 in connection with different application areas (e.g. home, medical informatics, transport informatics, industrial communications, RFID etc) as well as JTC 1 SCs roles in these application areas
- 2) Review and identify
  - the unique characteristics of Sensor Networks and the commonalities and differences with other networks
  - the system architectures of Sensor Networks in terms of functionalities
  - the entities that together comprise Sensor Networks and their characteristics
  - existing protocols that can be used for Sensor Networks and the elements of protocols that are unique to Sensor Networks
  - the scope of infrastructure that can be considered to be a Sensor Network
  - the types of data that need to be handled (acquired, processed, transported, stored, rendered etc) by Sensor Networks and any specific QoS attributes required by those categories
  - the interfaces that need to be supported by Sensor Networks
  - the services that need to be supported by Sensor Networks
  - aspects such as security, privacy, identification that may be relevant to specific Sensor Networks
- 3) Monitor other activities in international standardisation bodies and consortia and fora where specifications related to Sensor Networks are being developed.
- 4) Produce a report covering 1) and 2) above and information on other relevant standardisation activities
- 5) In the light of published SC scopes and work programmes and the results of 1) to 3) recommend potential areas of work to JTC1 and appropriate SCs and establishment of appropriate liaison

relationships to ensure that all necessary aspects of Sensor Networks within the scope of JTC1 are standardised

- 6) Recommend how the work on Sensor Networks can be efficiently coordinated in JTC1.
- 7) The SGSN may hold workshops to gather requirements or publicise the results
- 8) Meetings of the group may be physical or via electronic means

Membership in the SG will be open to:

- JTC 1 National Bodies and Category A Liaisons, AROs and PAS submitters
- JTC 1 SCs
- members of ISO and IEC Central Office
- ISO or IEC TCs, SCs, WGs in liaison with JTC 1 or its subgroups

In addition, the Convener may invite experts with specific expertise in the field

JTC 1 instructs the SGSN Convener to provide a report on the activities of the SGSN at the 2009 JTC 1 Plenary meeting in Israel.

#### **Resolution 45 – Contributions to the Study Group on Sensor Networks**

JTC 1 recognizes that SGSN needs additional contributions from SGSN members on their existing and potential areas for standardization related to sensor networks. Therefore, JTC 1 requests JTC 1 National Bodies and instructs its Subcommittees and invites Category A liaisons, AROs and PAS Submitters to submit contributions on document N9359, SGSN Technical Document version 1.

#### **Resolution 47 - Establishment of Study Group on Digital Content Management and Protection**

JTC 1 notes the standardization activity within JTC 1, ISO, IEC and in many consortia in the area of digital content management and protection. This a challenging area for standardization to cover a wide spectrum of technical, user, application needs. There is currently no activity to survey global standardization activities in this area and consider feasibility for coordination.

To this end, JTC 1 establishes a Study Group on Digital Content Management and Protection to understand the current state of standardization and to explore a possible role for JTC 1. The Study Group will have the following terms of reference:

- 1) Provide a definition for Digital Content Management and Protection
- 2) Assess, via an inventory, the current state of standardization in DCMP within JTC 1 and in other SDOs and consortia
- 3) Understand and document market/application segments, user requirements and the challenges to be addressed
- 4) Deliver recommendations to JTC 1 on possible actions to be taken
- 5) Meetings of the group may be via face-to-face or preferably by electronic means

Membership in the Study Group will be open to:

- 1) JTC 1 National Bodies, Liaisons, AROs and PAS submitters
- 2) JTC 1 SCs
- 3) Members of ISO and IEC central offices
- 4) Invited SDOs and consortia that are engaged in standardization in DCMP

In addition, the Convener may invite experts with specific expertise in the field

JTC 1 appoints Mr. Lin GAO as Convener and Mr. Linpeng GAO as Secretary for the Study Group of DCOMP and instructs the JTC 1 Secretariat to issue a call for participants for the Study Group.

JTC 1 instructs the Study Group Convener to provide a report on the activities of the Study Group at the 2009 JTC 1 Plenary meeting in Israel.

Unanimous

**Resolution 48 - Co-ordination and Funding of meetings**

JTC 1 instructs its subgroups to make every effort to ensure that meeting venues and dates are well coordinated with related meetings, and not changed within 2 months prior to the meeting; and reminds its subgroups of the restrictions on the funding mechanisms for meetings as per clause 7.4. of the JTC 1 Directives.

**Resolution 49 - Clarification on Consistency of Standards vs Competing Specifications**

JTC 1 notes the nature of standardization is to attract innovative ideas from multiple sources, choose the best ones and codify them in specifications that facilitate widespread use.

Further, consistent with ISO's and IEC's "one standard" principle (for example TMB's policy and principle statement on Global Relevance), there are times when one standard is all that is required to meet the needs of the marketplace, especially in a particular application area, and there are other instances where multiple standards make the most sense to respond to market requirements and to the needs of our society. In reducing the number of alternatives to a reasonable minimum, JTC 1 and other SDOs have demonstrated that it is not necessary and may not be desirable to choose only one alternative or option for standardization.

Further, JTC 1 notes that the cycle of innovation in the ICT sector has resulted in the continuous introduction of new technologies that improve upon existing standards. Any attempt to choose only one standard would ignore and threaten to inhibit the cycle of innovation that continues to fuel this industry.

Therefore, JTC 1 recognizes its commitment to ISO's and IEC's "one standard" principle; however, it recognizes that neither it nor its SCs are in a position to mandate either the creation or the use of a single standard, and that there are times when multiple standards make the most sense in order to respond to the needs of the marketplace and of society at large. It is not practical to define, a priori, criteria for making these decisions. Therefore each standard must be judged by the National Bodies, based on their markets, on its own merits.

A proposed document revision from a project editor, which incorporates comments received prior to the meeting and which is intended to be developed further at the meeting, provided they are received at the Secretariat's office in a form suitable for immediate posting, not later than **25 September 2009**.

The final agenda for adoption and use at the Tel Aviv Plenary will be posted to the JTC 1 web site on **2 October 2009**.

For contributions submitted via email, the JTC 1 Secretariat will provide a mechanism by which the submitter will be notified that the contribution has been received at the Secretariat's office. Nevertheless, ultimately the submitter is obligated to ensure receipt by:
