#### **Status of DRs processed at this meeting:**

#### **DR 08-0001 — REMOVAL OF ST\_PERCENTAGEDECIMAL FROM THE STRICT VERSION OF THE SCHEMA**

[See WG4 N 0044] Shawn described the DR. RNG schema needs a change for this one. ST\_PercentageDecimal is asserted to have been already defined; once verified, we should remove the instructions to add this simple type to Part 4.

#### **DR 08-0002 — FORMAT OF ST\_POSITIVEPERCENTAGE VALUES IN STRICT MODE EXAMPLES**

[See WG4 N 0044] Prose change needed to address “1000ths of a percent” issue; changes have been made, now in last call.

#### **DR 08-0003 — FORMAT OF ST\_POSITIVEPERCENTAGE VALUES IN STRICT MODE EXAMPLES**

[See WG4 N 0044] Shawn corrected a typo; was moved to last-call status after the call.

#### **DR 08-0004 — TYPE FOR PRSET ATTRIBUTES**

[See WG4 N 0044] Will be moved to last-call status after Murata-san provides RNG changes.

#### **DR 08-0005 — DESCRIPTION OF HSL ATTRIBUTES LIGHTNESS AND SATURATION**

[See WG4 N 0044] No changes to proposed solution, so moved to last call status.

#### **DR 08-0006 — DESCRIPTION OF RGB ATTRIBUTES BLUE, GREEN AND RED**

[See WG4 N 0044] No changes to proposed solution, so moved to last call status.

#### **DR 08-0007 — FORMAT OF ST\_TEXTBULLETSIZEPERCENT PERCENTAGE**

[See WG4 N 0044] RNG schema fragments are missing; Murata-san will provide these.

**DR 08-0008 — FORMAT OF BUSZPCT PERCENTAGE VALUES IN STRICT MODE EXAMPLE**

[See WG4 N 0044] Ready to go to last-call status with DR 08-0007 after that response is completed.

**DR 08-0012 — SCHEMAS: SUPPOSEDLY INCORRECT SCHEMA NAMESPACE NAMES**

Jesper went over the document that he and Shawn created, which describes the current proposal to change the namespaces in Strict and extend the conformance attribute for Transitional.

There was consensus that WG4 needs to resolve this DR.

**Action:** Jesper and Shawn will create a list of specific namespace changes to be made for conformance class Strict.

**DR 08-0014 — Shared MLs, Shared Simple Types: ST\_String example description error**

We discussed a change proposed by Murata-san, removal of text in ST\_String. Moved to last call.

**DR 09-0022 — SML: Incomplete set of format symbols for numFmts**

Moved to last call status

**DR 09-0033 — DML, Charts, Simple Types: Lack of support for percent sign**

[See WG4 N 0044] This proposal needs redlining of changes restored, for review by WG4. Shawn will work on restoring these.
